- Deputation/Absorption of officials in the Department of Posts: From amongst the regular Dispatch Rider (Group- C) and Group-C employees in the Pay Matrix Level- 01 as per 7th CPC in the Department of Posts, who possess valid Driving License for light and heavy motor vehicle on the basis of a Driving test to assess the competency to drive light and heavy motor vehicle.

- For Armed Forces Personnels: The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualification prescribed shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces thereafter they may be continued on
- Regulation of pay and other terms of Deputation/ Absorption. Pay Matrix 3. Level -02 as per 7th CPC and will be regularized as per pay rule.
- Age limit: The maximum age limit for appointment by Deputation/Absorption shall be not exceeding 56 years as on the closing date of receipt of applications.
- Period of deputations. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment 5. in the same or some other department of the Central Government shall ordinarily not exceed three years.
